Goods

- 3) Supply of Gem Testing Laboratory Equipment and Assay Laboratory Equipment.
- 4) Supply of Office Equipment. (Photocopy Machine / Fax Machines / Scanners / Duplicator Machine,)
- 5) Printing Items (Banners, Posters, Name Boards, Leaflets, Magazines)
- 6) Supply of uniforms. (Textiles and Shoes)

- 7) Event Management and Construction of stalls

Condition

- 2) A photocopy of the receipt obtained after payment of a non-refundable registration fee of Rs.1, 000.00 + VAT should be attached with the application.
- 3) If you want to register for more than one item or service, separate applications should be sent for each number and a registration fee of Rs.1, 000.00 + VAT will be charged for each additional application.
- 4) All applications should be submitted on or before 09.12.2021 by registered post or to the Supply Division at the address given below and at the top end of the envelope should be marked "Registration of Suppliers 2022".
