8. All bids must be accompanied by payment receipt or a Bid Security Valid in 119 days in the form of a Bank Guarantee using the format given with the Bidding Documents in Sri Lankan Rupees Four Hundred Thousand. (LKR 400,000.00) (Valid Period : 03.07.2026 - 30.10.2026)
9. Bids shall be valid for a period of 91 days from the date of deadline for submission of the bids (03.07.2026 to 02.10.2026).
