8. All bids must be accompanied by payment receipt or a Bid Security Valid in 119 days in the form of a Bank Guarantee using the format given with the Bidding Documents in Sri Lankan Rupees One Hundred Thousand. (LKR 100,000.00) (Valid Period : 25.08.2026 - 22.12.2026)
9. Bids shall be valid for a period of 91 days from the date of deadline for submission of the bids (25.08.2026 to 24.11.2026).
10. Bids will be opened immediately after the deadline for submission of bids, in the presence of bidders or their authorized representatives who choose to attend in person at the address stated above. (in Para 5)
